For each visitor to our website, our server records:

- IP address of visitor
- Date and time of visit
- Files viewed
- Referrers (page viewed just prior to site visit)
- Web browser software used.

The server housing our website and e-mail does not set any cookies. Cookies refer to unique packets of information that a server can transfer to a visitor's computer.

SPAM

Fulton County Health Department only collects the information necessary to respond to your requests for information and/or when you wish to submit comments via "Contact Us." In these instances, we may ask for your name, e-mail address, and other appropriate information needed to provide you with these services.

If you choose to give us personal information for any of the purposes above, this information is retained by the Fulton County Health Department and may be used by the Fulton County Health Department to support your customer relationship with us. We do not share, rent, or sell our lists to other companies. Fulton County Health Department does not approve of SPAM also known as UCE (unsolicited commercial e-mail). Fulton County Health Department does not send SPAM and it does not act as a relay point for SPAM from other mail servers. E-mail and Form Information

If a member of the general public sends the Fulton County Health Department (FCHD) an E-mail message or fills out a Web-based form with a question or comment that contains personal identifying information, that information will only be used to respond to the request and to analyze trends. The message may be redirected to another government agency or person who is better able to answer the question. Such information is not used in any way that would reveal personal identifying information to outside parties unless FCHD is legally required to do so in connection with law enforcement investigations or other legal proceedings.

However, the Fulton County Health Department does comply with court orders requesting the release of information about access to our web site, log files, etc. In the event of an eminent threat, the Federal "Patriot Act" requires us to turn over all information to law enforcement officials even in the absence of a court order. The court orders and the Patriot Act could force a release of information. Some court orders are accompanied by a "gag" order that prevents us from notifying a customer that we have released his/her information to authorities.
